WE ARE WORKING TO EXPAND ACCESS TO NATURE, CREATE HEALTHIER AND GREENER URBAN SPACES, AND BUILD STRONGER CONNECTIONS BETWEEN PEOPLE AND THE NATURAL WORLD, ENSURING THESE SPACES WILL INSPIRE AND BENEFIT COMMUNITIES FOR GENERATIONS TO COME.

IN 2024, MORE THAN 1,200 PEOPLE ATTENDED NEW JERSEY CONSERVATION-LED EDUCATION AND OUTREACH PROGRAMS, INCLUDING FREE FISHING DAY IN CAMDEN, "BIG DAY" AND "BIG SIT" BIRDING EVENTS IN JERSEY CITY, CADWALADER PARK BIRDING EVENT IN TRENTON, COFFEE & CONSERVATION SERIES AT BAMBOO BROOK OUTDOOR EDUCATION CENTER, PINE BARRENS PLANT COURSES, AND MORE.

GREEN & HEALTHY CITIES INITIATIVE WE BEGAN LAYING THE FOUNDATION FOR THE LAUNCH OF A STATEWIDE INITIATIVE TO INCREASE GREEN INVESTMENTS IN URBAN COMMUNITIES. IN 2024, WE CONVENED A STATEWIDE URBAN TREE FORUM THAT BROUGHT TOGETHER REPRESENTATIVES FROM CAMDEN, TRENTON, ELIZABETH, AND NEWARK TO TALK ABOUT GREEN INFRASTRUCTURE INVESTMENTS IN NEW JERSEY'S CITIES.

MORE 2024 SUCCESSES

WE OPENED THE GREGORY ROMANO TRAIL AT MENANTICO PRESERVE, CREATING A NEW OPPORTUNITY FOR OUTDOOR RECREATION IN CUMBERLAND COUNTY, WHICH HAS A LOT OF PRESERVED FARMLAND BUT NOT MANY HIKING OPPORTUNITIES IN NATURAL SETTINGS.

WE PLANTED NEARLY 400 SHADE TREES ALONG URBAN STREETS IN TRENTON AND IN CAMDEN'S GATEWAY PARK. THESE TREES HELPED REFOREST CITY PARKS THAT HAVE SUFFERED SIGNIFICANT TREE LOSS AND CREATED COOL, SHADED STREET CORRIDORS TO REDUCE THE URBAN HEAT ISLAND EFFECT AND IMPROVE OVERALL QUALITY OF LIFE.

WE PARTNERED TO LAUNCH TREES FOR TRENTON, A COMMUNITY TREE-PLANTING INITIATIVE TO INCREASE GREEN SPACES IN THE CITY, AND INTRODUCED "TRENTON WALKS!", A COMMUNITY ENGAGEMENT PROGRAM THAT FEATURES WALKS IN AND AROUND NEW JERSEY'S CAPITAL CITY.

WE CONTINUED IMPORTANT ADVOCACY WORK HELPING TO SECURE FUNDING FOR CAPITAL STATE PARK IN TRENTON AND CREATE THE BEST FUTURE FOR LIBERTY STATE PARK.
